Mayor Rodney Dood called the meeting to order at 4:30 p.m. in the Council Chambers of the Iron River City Hall. The Pledge of Allegiance was recited.

Roll Call – Dennis Powell, Anthony Clements, Ronjo Leonoff and Rodney Dood. Absent – 1: Benjamin Garcia.

Also Present – City Manager Rachel Andreski, City Clerk, Tyana Elenbaas and Interim City Attorney Hannah Goodman, Craig Richardson (WICKWIRE), Gary Cronkright, Adam and Mark Polley, Chief Harrington and Officer Kezerle.

**OLD BUSINESS**

**Used Car Sale**

Andreski explained that she obtained five quotes from Riverside Auto for the 2015 Dodge Charger. Dood calculated the average quoted amount was around \$5,715. Leonoff stated that he had googled the value of a 2015 Dodge Charger and was given a quote of around \$8,000. Clements stated we should list at the highest quoted price. Leonoff motioned with the support of Clements to list the 2015 Dodge Charger for \$8,000.

**Sale of City Property (054-482-025-00)**

Andreski stated that this is the same property that the Council had placed a counteroffer of \$1,000 plus City costs. Mr. Westphal will agree to the counteroffer, if the City cleans up debris from the lot. There's remaining concrete from a sidewalk from the house that was there previously, clothesline poles and other smaller concrete on the property currently. Jeff Andreski surveyed the lot and stated it would be a quick and easy project to clear out the concrete and the other debris. Leonoff motioned with support from Powell to agree to the \$1,000 plus City costs and having the DPW workers clear out the debris from the lot.

Richardson stated that we received two bids for this project, and Ryan's Excavating, LLC had the lowest bid at \$14,048. FA Industrial Services was significantly higher at \$50,391. Powell motioned with support from Leonoff to accept the bid from Ryan's Excavating, LLC at \$14,048.
